AoH hosts an online forum for survivors of suicide loss for over 15,400 members worldwide & launched a new mobile-friendly website. The forum operates as a 24/7 support group and is supervised by a mental health counselor and a trained team of survivor moderators. It transcends time and distance, reaching those who have little to no specialized support. The website contains vital information and resources to help loss survivors understand and cope with the complex aftermath of suicide. AoH provides personalized grief consultations and responds to hundreds of inquiries each year from those seeking help. AoH exhibited at the American Association of Suicidology & the International Funeral Directors Conferences (cont. below)
